Tools required for works
The Landmate crew can organise tools for the job from the information you provide. The crews have their own equipment trailer with a range of tools. Detailed information from the landholder will benefit productivity on the day. Please advise us of any equipment that may make the job easier, for example: picket lifter, picket driver, wire genie, back pack sprayer.

Terms and conditions for the Landmate environment program

Time limits – Landmate aims to have a time limit of one week of work per landholder to allow work to be evenly shared. (Landmate management may vary amounts of time worked at any one property or project, if crews have available time.)

Cancellations by Landmate – Landmate crews are unable to work in extreme conditions. Work will be cancelled and rescheduled if a day of total fire ban is declared, or heavy rain is forecast.

It is possible, in unexpected circumstances, that work may be cancelled on the day. The primary responsibility of crew leaders is the supervision and safety of prison work crews. If a situation arises concerning security or safety, this responsibility will take precedence over labour activities.

Cancellations by the landholder or project owner – If, as a landholder or project owner you wish to cancel work, you must ring the Landmate crew leader to advise them as early as possible (preferably several days in advance).

In the event of a cancellation, Landmate is not obligated to rebook another time for works, but we will endeavour to ensure that if you wish to rebook it will be done at the earliest available time.

Work finished early – If crews finish work earlier than expected, it is at the discretion of the crew leader to determine the work schedule for the rest of the day.

Landholders/project owners need to be onsite during works – Landholders/responsible project owners must be present on site at the designated time of arrival and be present to work with the crew or to explain details of the necessary works to the crew leader. Crew leaders perform worksite assessments, however if work place inductions are required, it is the responsibility of landholders/project owners to conduct these.

Access to work sites - Crews use four wheel drive vehicles with heavy duty tool trailers in order to gain access to remote rural worksites.

Land-holders/project owners need to:

- · make every effort to ensure that crews can travel safely to the worksite, while on their land
- provide crew leaders with clear direction to reduce any risks from wet, hilly or rough terrain.

Crew lunch - Crews provide themselves with all hospitality needs with the use of food storage, a BBQ or cut lunch daily.

On ground works – End assemblies must be in position and the length of fence line to be erected must be clear of any obstructions, including vegetation.

Revegetation works – Worksites must be prepared before planting commences. For example: fences constructed, ground ripped, with weeds and vegetation sprayed or managed prior to work commencing.

Chemical use – Landmate follows the Agriculture Victoria "The Agricultural Chemical User Permit (ACUP) system" to ensure safe use of chemicals and requires all landholders/projects owners to operate according to this system.

Prisoner (crew member) assessment – Each prisoner is assessed by the prison location and their security rating, history and overall behaviour is considered before placement in an outside work team. At no time can the prisoner's offence history be disclosed.

Applications for 'Partnership 5 Government funded projects (other than DELWP)' – attract a \$450 per crew per day plus GST labour fee for the use of Landmate crews. This rate is subject to periodic review and will be updated herewith in the event a rate change applies.

Credit application process for services attracting fees

Organisations accessing services under Partnership 5 may need to follow the credit application process of the Corrections Victoria's Prison Industries unit by contacting a Landmate representative prior to any works commencing.

Privacy statement

The Prison Industry Prisoner Landmate Environment program (Landmate) provides services for eligible environmental projects in some parts of regional Victoria. The service is delivered by Corrections Victoria, part of the Victorian Department of Justice and Community Safety.
